my judicial duties, and I will do right to all manner of people after the laws and usages of the Republic of Singapore without fear or favour, affection or ill-will to the best of my ability, and will preserve, protect and defend the Constitution of the Republic of Singapore.

It's noteworthy that the "President, Member of Parliament, Chief Justice, Supreme Court Judge, Judicial Commissioner or Senior Judge" except for the Prime Minister share the same OATH to "preserve, protect and defend the Constitution of the Republic of Singapore" which include the "sovereignty of the Republic of Singapore as an independent nation" under Article 6 of the Constitution of the Republic of Singapore.
