chronic counselling scams paid by public monies" orchestrated by Family Justice Courts (mastermind), MSF (CPS) and SSAs through the use of a review committee on the Family Services Landscape. Public servants must look at "counselling fraud or chronic counselling scams paid by public monies" as a national security issue (Malaysia's covert and deceptive foreign interference) and not just ordinary irregularities/malpractices for the sake of money. Malaysia (the Malay sultans who descended from Indian Muslims) will have full control of Singapore's society by controlling the judiciary (incl. FJC), MSF and SSAs through covert and deceptive means. All judges in Singapore's judiciary come from privileged/wealthy backgrounds, hence they're agreeable to impede the upward mobility of children born to low-income Singaporeans to protect their own children from "future competition" from children born to low-income Singaporeans. Judges are also aware that the "sovereignty of the Republic of Singapore as an independent nation" belongs to Malaysia through covert and deceptive means, hence when a litigant has no defence lawyer - the judge can always apply the law as what she thinks it should be instead of applying the law as it is. A layman doesn't have a "lawyer licence" to question the judge whether she is applying the law as it is, or as what she thinks it should be.

Social workers from SSAs will preserve, prolong and perpetuate the "root causes of family conflict" for the sake of their "pay-per-session counselling fees" - the policymakers who designed this remuneration scheme have the intention to impede the upward mobility of children born to low-income Singaporeans, knowing that such a remuneration scheme would motivate social workers to preserve, prolong and perpetuate the "root causes of family conflict" for as long as possible instead of solving problems for the family. There's no money to be earned once the case is closed. All in all, "counselling fraud or chronic counselling scams paid by public monies" serves 2 purposes - impede the upward mobility of children born to low-income Singaporeans for privileged/wealthy judges and endless counselling fees for social

he is to conduct himself as such public servant, intending to cause, or knowing it to be likely that he will, by such disobedience, cause injury to any person, shall be punished with imprisonment for a term which may extend to one year, or with fine, or with both.

On 31 March 2022, I received a WhatsApp message from Daneel (CPS investigation) telling me to attend the Youth Court on 04/04/2022 without the Zoom meeting ID and passcode. I didn't receive any email (or delivery by hand) containing the Zoom meeting ID and passcode as well as the statement of claim from CPS regarding the Youth Court hearing on 04/04/2022. CPS already has my email address since 19 May 2021 when I was communicating with PEK Siao Tian. It's the obligation of CPS to serve their statement of claim to me. Delivery of the statement of claim is the "most important process of taking someone to court" under the Rules of Court universally. CPS had knowingly disobeyed the direction of Family Justice Rules 2014 (sections 148B, 148C) intending to cause injury to me and the Government of Singapore.

I could see that CPS is knowingly going all out to disobey the direction of the Children and Young Persons Act 1993 (section 4) intending to cause injury to my "care and control ancillary order from the Syariah Court" by directing their FSC/SSA contractors/partners to coach Sumi to hate her own father over a period of more than 1 year for the unconstitutional/unlawful purposes of impeding the upward mobility of children born to low-income Singaporeans as well as running counselling fraud or "chronic counselling scams paid by public monies" for the pecuniary gains of their FSC/SSA contractors/partners. The direction of the Children and Young Persons Act 1993 (section 4) is always reintegration with parents (CZ v DA and another 2004). There appears to be an "unspoken policy" by CPS to victimize Muslims - a "covert warfare" directed against the Malays, who are the indigenous people of Singapore, because "Chinese and Indian Singaporeans" who have the general direction and control of the Government aren't

Valerie Thean works as a judge of the High Court. She was previously the Presiding Judge of the Family Justice Courts, and prior to that, held various posts in the Singapore Legal Service and public service. She is a member of Barker Road Methodist Church and is married to Mark.

I note that Justice Valerie Thean is a director in Epworth Community Services but judges holding directorships in the social service industry or other industries would undermine the public perception of their independence and the independence of the Judiciary as an institution - I don't think I need to explain further about the social service industry or other industries having judges in their board of directors to symbolize some form of judicial backing. I'm unsure whether Justice Valerie Thean receives director's fees in Epworth Community Services.

It appears that Christian organizations are dominating the social service industry. I noticed that Care Corner Singapore, Fei Yue and Epworth Community Services are all Christian organizations. It's unwise to appoint Mr Aubeck Kam as the permanent secretary for both MSF and MHA because the SPF would "feel disinclined" to investigate into fraud in the public sector involving government agencies, charities, societies and other public organisations.
