Incident linked to G/20241115/7039. My child and I are victims of corruption (public sector). I'm lodging this report to preserve, protect and defend the "sovereignty of the Republic of Singapore as an independent nation (incl. Commonwealth citizenship)" for all Singaporeans (esp. indigenous Malays).

I refer to <https://www.channelnewsasia.com/singapore/stabbing-priest-mouth-st-joseph-church-basnayake-keith-spencer-4739646> (see below)

Spencer is accused of using a foldable knife to stab Fr Lee in the mouth at about 6.30pm on Nov 9 at St Joseph's Church at Upper Bukit Timah.

The charge stated that the action caused an 8cm-long laceration on Fr Lee's tongue, a 3cm cut on his upper lip and a 4cm cut on the corner of his mouth.

The alleged attack took place during communion at the parish's monthly children's mass, where children take on duties that adults usually undertake, such as singing in the choir.

According to Home Affairs Minister K Shanmugam, Spencer is Singaporean Sinhalese and had previously declared to the Immigration and Checkpoints Authority that he is Christian.

A "harmful AI-powered satellite psychotronic response" to judicial corruption directed at Chief Justice Menon, who's a well-known Catholic. enforcement top brass should earn 70% of lower court judges' salaries. An annual pensionable salary of S\$347,400 for the Chief Justice is only 15% of the PM's annual salary - a demeaning pay disparity resulting in judicial corruption.
