SINGAPORE - A traction power fault disrupted commutes along the northern stretch of the North-South MRT Line for more than two hours during peak traffic on June 3.

Transport operator SMRT said the fault, which occurred at about 5.50pm, meant that no trains could travel from Choa Chu Kang to Woodlands.

Preliminary investigations so far found that a lightning strike caused traction power to trip, and a small fire had broken out in a power control box next to the train track, about 20m from the platform of Kranji station.

I took the MRT from Choa Chu Kang to Marsiling on 3 June 2024 at 3:35PM, hence I suspect this lightning strike is a harmful satellite response to L/20240424/7002 and I suspect the AI command is "Disrupt MRT services from Choa Chu Kang to Marsiling using a lightning strike in response to the abuse of the law to remind public servants not to abuse the law" and I'm deeply sorry to hear about the death of Zdulfika (https://str.sg/LoBd), which occurred in relation to the execution of his duty as a public servant.

Restriction on publication of information leading to identification of child or young person who is subject of investigation, etc.

- (2) A court may --
- (a) on the application made by the Director-General or a protector, order a person to remove the publication, or stop the broadcast, of any information or picture that is in contravention of section 27A(1) as in force immediately before 1 July 2020 or subsection (1)(a); or
- (b) on the application made by the protected person, order a person to remove the publication, or stop the broadcast, of any information or picture that is published or broadcast in contravention of subsection (1)(b).
- so long as the court is satisfied, on a balance of probabilities, that the order is necessary for the protection and safety of the child or young person concerned or the protected person, as the case may be.

According to parliamentary intention and purpose, neither the SPF nor the AGC can decide, on the balance of probabilities, whether to remove a publication for the protection and safety of the child or young person concerned or the protected person, as the case may be.
