# LTA enforcement officer who died while chasing errant rider was looking forward to his wedding in July

SINGAPORE – He had sent out wedding invitations, finished the last of his preparations, and was looking forward to celebrating the joyous occasion with his family and friends in July.

But Mr Zdulfika Ahakasah, 26, met a tragic end on the morning of June 4. The Land Transport Authority (LTA) enforcement officer crashed his motorcycle <u>while chasing another rider who</u> <u>was attempting to flee.</u>

He was taken to hospital, where he subsequently died, the police said.

An 18-year-old man, believed to be the rider the officer was chasing, was arrested for suspected drug-related offences, possession of scheduled weapons, and various driving-related offences, added the police. In a Facebook post on June 5, Minister of State for Home Affairs and National Development Muhammad Faishal Ibrahim said the man was arrested in a residential unit along with a girl, 17, and a woman, 33, who were also detained for drug-related offences.

The man was also wanted by the Central Narcotics Bureau for prior drug consumption offences, Associate Professor Faishal added.

A video of the incident posted on the SG Road Vigilante – SGRV Facebook page shows the officer on his motorcycle pursuing a rider on the shoulder lane near an expressway exit.

The rider appears to be slowing down his motorcycle at first, but then makes a sudden swerve to the right and cuts into the path of a lorry.

The officer follows closely behind, before crashing his motorcycle into a road divider.

Transport Minister Chee Hong Tat said in a Facebook post on June 5 that the case is being investigated by the LTA and Traffic Police.

He said: "I am extremely saddened by the tragic news that an LTA enforcement officer, Mr Zdulfika Ahakasah, had died... Our enforcement and front-line officers perform their duties with courage and dedication."

Mr Zdulfika's brother, Mr Radin Ilahi Ahakasah, told The Straits Times on June 5 that Mr Zdulfika was excited about getting married. He had known his fiancee for about five to six years.

The 47-year-old said he received a call from his sister at around 11am on June 4 that Mr Zdulfika, who was the youngest of six siblings, had been taken to hospital.

Mr Radin, who works as a personal driver, said: "Once I got the

call, I rushed to the hospital and was the first of my family members to reach there. The doctor told me that my brother was gone, and I couldn't believe it."

He added that his parents and Mr Zdulfika's fiancee Nur Syaina were heartbroken when they found out he had died.

He said: "At the hospital, my mother was crying and shouting, 'Please save my son! Please give me back my son!'

"His fiancee was also in a very bad state. She has been crying since yesterday, and it's painful to see her like that."

Mr Zdulfika's oldest sister, Ms Siti Werdanengsy, said he was a kind and lovable brother who enjoyed making his family laugh.

"He was a happy-go-lucky person and had lots of friends. There was always a smile on his face. He never got angry," the 49-year-old housewife said.

She added that he would often go the extra mile to take care of his siblings even after they moved out of the family home in Ang Mo Kio.

Mr Radin said that Mr Zdulfika, who had previously worked in the police force and Aetos, took his work as an LTA enforcement officer very seriously.

He said: "His boss told me that my brother was very hardworking, never gave any excuses and saw his job as a big responsibility."

# Couple met at polytechnic

The hearse arrived at Mr Zdulfika's Housing Board block in Ang Mo Kio at about 2pm.

More than 50 friends and relatives had gathered at the flat,

which the LTA officer shared with his mother, from 10am.

Mr Sapiee Noordin, 78, a neighbour who lives on the second floor of the same block, said it was as if he had lost a grandson.

He said Mr Zdulfika was a polite man who would always greet him when they bumped into each other at 5.30am, as the LTA officer was leaving for work and Mr Sapiee was heading to the mosque.

Miss Nur Syaina's mother, who did not give her name, was at Mr Zdulfika's flat with her daughter, who was inconsolable.

She said in Malay: "We accept our fate, but it is a very difficult time for my daughter."

Miss Nur Syaina's uncle Rosli, 45, said the couple met when they were students at Temasek Polytechnic.

"Everything for the wedding had been settled, including the honeymoon. Now we're just trying to make sure Nur Syaina is cared for," he added.

Several of Mr Zdulfika's friends from Temasek Polytechnic also turned up at the family home.

Mr Azri Ramdan, 28, shared that the last time they all met was about two years ago.

"He was already riding a motorcycle when we were students. He was not an inexperienced rider by any means," Mr Azri said, adding that his friend was a family man who was always jovial.

The last fatal accident involving an outrider performing LTA enforcement duties was in 1990.

Corporal Tan Tiang Hwa, who was with the Registry of Vehicles, which later merged with three public entities to form the LTA, was killed after he stopped a lorry along Jalan Ahmad Ibrahim that reversed into his motorcycle.

In 2017, Traffic Police Staff Sergeant Nadzrie Matin, 29, died following <u>an accident along Serangoon Road</u> where he was performing his duties.

The accident on June 4 comes in the wake of a fatal incident in May, which saw 30-year-old firefighter, Captain Kenneth Tay Xue Qin, <u>killed while fighting a fire on a ship.</u>

He was the second Singapore Civil Defence Force firefighter to die in the line of duty.

# Restriction on publication of information leading to identification of child or young person who is subject of investigation, etc.

**111.**—(1) A person must not, without the Director-General's approval, publish or broadcast —

- (a) any information or picture that identifies, or is likely to lead to the identification of any child or young person as a child or young person who
  - (i) had been or is the subject of any investigation under this Act;
  - (ii) had been or is arrested on or after 1 July 2020, for an offence committed under any written law;
  - (iii) had been or is taken into care or custody by the Director-General, a protector, any officer generally or specially authorised in that behalf in writing by the Director-General or a protector or a police officer under this Act;
  - (iv) had attended or is attending a family programme in relation to an application to be made under section 59; or
  - (v) was or is the subject of an order made by a court under this Act; or
- (*b*) any information or picture mentioned in paragraph (*a*) even after the child or young person attains 18 years of age (called in this section the protected person).

- (2) A court may
  - (a) on the application made by the Director-General or a protector, order a person to remove the publication, or stop the broadcast, of any information or picture that is in contravention of section 27A(1) as in force immediately before 1 July 2020 or subsection (1)(*a*); or
  - (b) on the application made by the protected person, order a person to remove the publication, or stop the broadcast, of any information or picture that is published or broadcast in contravention of subsection (1)(b).

(3) The court may make an order under subsection (2) even if —

- (*a*) the application is not served on the person against whom the order is to be made (called in this section the respondent) or is not served on the respondent within a reasonable time before the hearing of the application; or
- (*b*) where the application has been served on the respondent, the respondent does not appear at the hearing of the application,

so long as the court is satisfied, on a balance of probabilities, that the order is necessary for the protection and safety of the child or young person concerned or the protected person, as the case may be.

(4) If any information or picture is published or broadcast in contravention of subsection (1)(a) or (b) —

- (*a*) in the case of the publication of any information or picture as part of a newspaper or periodical publication, every proprietor, editor, publisher or distributor of the newspaper or periodical publication;
- (b) in the case of the publication of any information or picture otherwise than as part of a newspaper or periodical publication, the person who publishes or distributes it; or
- (c) in the case of the broadcast of any information or picture, every person who transmits or provides the programme in which the information or picture is broadcast, and every person having functions in relation to the programme corresponding to those of the editor of a newspaper or periodical publication,

shall jointly be guilty of an offence and shall each be liable on conviction to a fine not exceeding \$5,000 and, in the case of a second or subsequent conviction, to a fine not exceeding \$10,000.

(5) A court may, in addition to any punishment mentioned in subsection (4), order a person to remove the publication, or stop the broadcast, of any information or picture that is in contravention of subsection (1)(a) or (b).

# GE2020 official results: PAP wins Ang Mo Kio GRC with 72% against Reform Party

SINGAPORE - The People's Action Party team led by Prime Minister Lee Hsien Loong secured a resounding win in Ang Mo Kio GRC with 71.91 per cent of the votes against the Reform Party.

While slightly lower than their winning vote share in 2015 of 78.64 per cent, the result was a clear sign of support from voters in a campaign that may well be the last that Mr Lee, 68, leads as prime minister.

Back in 2012, he said in an interview that he hoped not to continue as prime minister beyond the age of 70, which would be in 2022. He has been prime minister for 16 years, since August 2004, and MP for Teck Ghee ward in Ang Mo Kio GRC since 1984.

PM Lee arrived at the PAP's Teck Ghee branch to applause just after 2am on Saturday (July 11) morning. He was accompanied by his wife Ho Ching.

On 13 March 2024 at 11:18 - I told CPO Benjamin (benjamin\_leow@msf.gov.sg), "Since this week is the March school holidays, Sumi can start to bring her things to her room this week. The whole process should take about 3 days to bring all her things over" and Benjamin replied at 11:22, "May I know what has changed that caused Sumi to give a different response this time? As I'm aware that previously she had been hesitant about moving back".

Benjamin took no action in regard to "Sumi wants to move in and live with me asap" and his inaction is an offence defined in section 166 (https://sso.agc.gov.sg/act/pc1871?ProvIds=pr1-,pr166-) as well as a violation of section 4 (https://sso.agc.gov.sg/Act/CYPA1993?ProvIds=pr1-,pr4-) because the direction of the law for CPO-000034-2022 is re-integration of the child to his or her family. 43 In ordinary circumstances, it would be in a child's welfare to be brought up by the child's parents. 44 This position is neither novel nor unprecedented. It is also consistent with a line with English cases. In Re H (A Minor) (Custody: Interim Care and Control) [1991] 2 FLR 109, the English Court of Appeal held at 113 that in a dispute over whether the child should live with a natural parent or some other family member (in that case, the grandmother), the applicable test is the child's welfare, and "there is a strong supposition that, other things being equal, it is in the interests of the child that it shall remain with its natural parents".

48 I noted that even if a child is determined to be in need of care or protection under s 4 of the CYPA, the child's parents do not fall out of the picture completely. While the state may intervene in such situations to remove the child from the parents' care at the relevant time, re-integration of the child to his or her family will still remain a desired goal. There may of course be cases where the unfitness of parents is so persistent and the long term prognosis of fitness so bleak that other goals are pursued instead. The welfare of the child remains the paramount consideration in all cases.

It's completely unacceptable that Benjamin didn't anticipate "Sumi wants to move in and live with me asap" at all. I suspect Benjamin is racist against indigenous Malays and therefore didn't want Sumi to reintegrate back into her family because my care and control ancillary order is from the Syariah Court. It looks like Malaysia's covert and deceptive foreign interference in the ruling PAP and the Singapore Public Service is deep-rooted, causing public servants to covertly harm our social cohesion domestically.
